<p>NAVAJO REGION - OPEN CONTINUOUS ANNOUNCEMENTS (OCA)</p> <p>This OCA allows the acceptance of applications through the open period of 09/30/15 with qualified applicants being placed on the register and referred for consideration as vacancies occur. The FIRST cut-off date for receipt/referrals of applications to be considered for available vacant positions will be 12/29/14. The SECOND cut-off date for receipt/referrals of applications to be considered for available vacant positions will be 02/02/15. The FINAL cut-off date for receipt/referrals of applicants to be considered for available vacant positions will be 09/30/15. Applicants with 10-point Veterans' Preference who submit a complete application after a cut-off date, but before a Certified List of Eligibles is issued, will be considered and referred, if qualified. Your applicant period of eligibility will be for six (6) months. The system automatically populates your Eligibility Begin Date when your application is rated and your Eligibility End Date is calculated on the start of the 6-month period of eligibility. You must reapply to keep your application active beyond an Eligibility End Date.</p>
