Dear Tribal Leader:

The National Park Service (NPS) invites you to consult on a draft version of the Indian Youth Service Corps Guidelines. The Indian Youth Service Corps is a new program established within the Public Land Corps through the John D. Dingell, Jr. Conservation, Management, and Recreation Act (Public Law 116-9) codified at 16 U.S.C. 1727b. The program offers Tribes and partner organizations the opportunity to enter into agreements with the Department of the Interior, Department of Agriculture, or Department of Commerce to, among other things, establish conservation crews to carry out conservation programs on eligible service lands.

The NPS is presenting these Indian Youth Service Corps Draft Guidelines as a starting point for your input based on the NPS's experience in implementing the Public Land Corps program and statutory parameters for the Indian Youth Service Corps program.
