Subject:	Authorization for Use of Government Passenger Carriers for Home-to-Work Transportation

STATEMENT OF ISSUE:

Request for Renewal Authorization for Use of Government Passenger Carriers (Fieldwork) for Home-To-Work Transportation Pursuant to 31 U.S.C. 1344.

ISSUE BACKGROUND:

Home-to-Work authorizations are for fieldwork activities and are only granted under the conditions and positions listed in Attachments 1 and 2 of the supplemental package. In accordance with the Federal Management Regulation (FMR), 41 CFR Chapter 102, the head of the agency is the only official who can authorize this type of transportation.

CONSTRAINTS ON SECRETARY OR DEPUTY SECRETARY FOR ACTION (include Office of Solicitor input if legal rationale is provided as a limitation on action):

This authority cannot be delegated. The duration of these authorizations will be for a period of two years.

PLEASE INDICATE IF TIME SENSITIVE:

OPTION 1: Approve the request to designate 319 positions for home -to- work privileges.

Views of other DOI Bureaus (if applicable):

The four DOI Bureau Fire Directors are in support of the designation and have accepted the requirements for additional record keeping and reporting.

The Office of Wildland Fire will direct bureaus to comply with Departmental policy regarding Home-to-Work record keeping and reporting, and ensure appropriate oversight by supervisors to mitigate risk. If instances of misuse are determined, the authorization would be withdrawn for the individual, and potentially for the reporting unit.

<u>Consistent with relevant EO's or SO's? (specify):</u>(Order No. 3336 Rangeland Fire Prevention, Management and Restoration)

Under this renewal authorization the Secretary would grant authority to allow the certain employees in specific cases the ability to use home-to-work government conveyance at the direction of their immediate approving line officers. Under this authority the Bureaus at the Regional or State level could further limit the use of this authority through supplemental policy.

Secretarial Priorities Advanced by Option:

Quick access to Government vehicles to engage such situations will substantially reduce response times and contribute to increased efficiency and effectiveness for Interior's Wildland Fire Management Program. Management in these situations must act swiftly to avoid the loss of life and property. The cost of lives and property saved will be immeasurable.

Outside Perspectives -Members of Congress?; Federal, State, Tribal, Territorial, and local government?; and Citizen groups?:

Other Federal agencies have adopted this same approach and are seeing it as a successful practice.

Traditional concerns to this type of policy have been cost, liability, and public perception. To manage those concerns several sideboards are included as part of this policy.

OPTION 2: No-Action

Views of other DOI Bureaus (if applicable):

With the dramatic growth of the wildland-urban interface, wildland fire agencies face additional challenges linked to firefighter and public safety as well as appropriate management actions. Often when the DOI initial response crews arrive, rural fire departments, private citizens, and associated equipment, are already on the scene. If the wildland fire is on or threatening DOI protection areas (i.e.: an area where DOI has the primary responsibility for attacking an uncontrolled fire and for directing the suppression action), it becomes the responsibility of the identified agency to manage the situation.

<u>Consistent with relevant EO's or SO's? (specify):</u> (Order No. 3336 Rangeland Fire Prevention, Management and Restoration)

There is a need to minimize exposure to firefighters and the public from an emerging incident. If the fire can be controlled in the fastest possible manner, then the complexity will be reduced, resulting in reduced exposure to firefighters and public.

Valuable time is lost when agency personnel travel from their residence to their duty station, retrieve a tactical command vehicle, and respond to an emerging incident. Many times the employee lives closer to the incident than to the duty station.

Secretarial Priorities Advanced by Option:

Annually, each affected agency has numerous situations where an immediate response by firefighters can directly reduce the damage to property and resources as well as limit the complexity of an emerging fire which results in lower threats to public and firefighter safety? Generally, scheduling modifications, fire

stations, and fire detection will allow firefighters to respond directly from their duty stations. The need for competent, qualified oversight on all fires is a key factor in reducing the risk profile.

Outside Perspectives - Members of Congress?; Federal, State, Tribal, Territorial, and local government?; and Citizen groups?:

In at least one recent court case the Bureaus have been held to significant amounts of liability for oversight on fires that are under federal jurisdiction but may have cooperators that are not under federal control. Costs of fires and resource damage are of great concern to the public as well as our agencies. Measures that reduce the extent and complexity of these incidents, while not incurring significant new

costs, may be worth consideration.) Approval

Attachment 2

Department of the Interior Wildland Fire Management Program Home-to-Work Transportation Authorization FY 2017 Request Record

In accordance with the Department of the Interior Motor Vehicle Management Handbook (April 2008), the following information is included in the request for authorization to use a Government passenger carrier for home-to-work-transportation:

(1) Job title and series number: The designated wildland fire program management positions include: Fire Management Officers (GS-0301/0401), Assistant Fire Management Officers (GS-0301/0401), and Fire Operations Specialists (GS-401/0455/0462).

(2) Duties of the position(s) which require the authorization: The positions designated may require the use of motor vehicles for the safe and efficient performance of field duties, which can include initial response to wildland fires for establishing command and control, and/or providing other leadership and oversight in an emerging incident.

The specific field duties of the Fire Management Officer (FMO) and Assistant Fire Management Officer (AFMO) positions include, but are not limited to:

(a) coordinates and initiates on wildland fires all fire management activities based on firefighter and public safety, cost effectiveness, and values to be protected consistent with resource objectives, by using the full range of strategic and tactical options as described in an approved Fire Management Plan.

b) coordinates operations with cooperating agencies on multi-jurisdictional wildland fires addressing risk to human safety and potential for damages to resources and improvements.

(c) manages the environmental and workplace hazards of the wildland fire environment and provides leadership and direction to subordinates in the recognition and mitigation of these hazards.

(d) responsible for the on-the-job safety and health of all employees supervised.

The specific field duties of the Fire Operations Specialist (FOS) position include, but are not limited to:

(a) assigns missions to ground and aviation wildland fire suppression resources. Makes efficient and effective use of multiple types of interagency wildland fire suppression resources with varying capabilities. Ensures common communications for interagency resources.

(b) provides protection for life, property and resources. Selects strategies and tactics to ensure safe operations for assigned resources. Recognizes potential hazardous situations and provides operational briefings. Initiates contacts with federal, state, and/or local law

enforcement personnel as necessary to close roads, evacuate structures, and deal with the public.

(c) participates in development of incident objectives and strategies and tactics, to provide for safe operations and cost effective incident management.

(3) The address of the pe1manent duty station: The information is provided in the table below.

(4) Type of passenger carrier: The information is provided in the table below.

(5) Justification - clearly citing the beneficial effects of work performance and expected results:

Use of Government passenger carriers for home-to-work transportation by those employee(s) occupying the described positions will substantially increase the efficiency and economy of the Department of the Interior under the circumstances described:

(a) extreme fire danger and/or high potential for above normal fire growth exists where an immediate response can directly reduce the damage to property and resources as well as limit the complexity of an emerging fire which results in lower threats to public and firefighter safety.

(b) response to wildland fire emergencies, or other circumstances, where there is an immediate, unforeseeable, temporary need to provide home-to-work transportation for the uninterrupted performance of the agency's mission, such as during periods of extreme fire danger.

(c) establishing command and control and/or providing fireline leadership in an emerging incident that results in minimizing exposure to firefighters and the public. The need for competent, qualified oversight on all fires is a key factor in reducing the risk profile.
