Subject: Fiscal Year 2022 Severity Rules, New Severity FireCodes, and Approved Short-Term

Severity Amounts for each Region

The Bureau of Indian Affairs (BIA) Branch of Wildland Fire Management (BWFM) has created new Short-Term and Long-Term Severity FireCodes for use in Fiscal Year (FY2022). The use of Severity funding must comply with the current Interagency Standards for Fire and Fire Aviation Operations (Red Book). Please refer to Chapter 6, "BIA Program Organization and Responsibilities," and Chapter 10, "Preparedness," for specific guidance on the use of Severity funding for Wildland Fire Operations. Please note that the "USFS Assist" box is not checked on any of the Severity FireCodes. This is because the USFS has a rule that they will not charge against a BIA Severity FireCode.

New Short-Term Severity (STS) FireCodes for Fiscal Year FY2022 and approved amounts are as follows:

Regional Fire Management Officers are responsible for determining business practices for STS use among their Agency and Tribal wildland fire programs. Line Officers and Fire Management Officers are responsible for ensuring that STS is used per standards identified in the Red Book and within the approved amounts identified above.

Long-Term Severity (LTS) requests will be submitted from Regional Offices to the BWFM through electronic mail (email) or hard copy mail. The BWFM will respond no later than two days upon receipt of the LTS request. Please note that email submittal is preferred to ensure expedited processing of LTS requests. LTS amounts and timeframes will be determined on a case-by-case basis according to the LTS request.

For FY2022, FireCodes have been pre-established for each Region for LTS and will be utilized for all LTS requests as follows:

The LTS FireCodes identified above are only authorized for use when LTS requests are approved and for their agreed timeframes. Regional Fire Management Officers are responsible for determining business practices for the benefit of LTS among their Agency and Tribal wildland fire programs. Line Officers and Fire Management Officers are responsible for ensuring that LTS is used per standards identified in the Red Book and within the amounts and timeframes approved with each request.

Given that the Federal Agencies that operate wildland fire programs and participate in interagency fire operations do not cross-bill each other, our Bureau must establish Severity Support FireCodes to be used for Severity Support to other jurisdictions. The Following Severity Support FireCodes have been developed for FY2022 for support to those jurisdictions by BIA and Tribal wildland fire programs:

Although the ordering Agency may issue a Severity FireCode on Resource Orders, it is required that the above-listed Severity Support FireCodes be used for any Severity assignment to those jurisdictions by BIA and Tribal (Tribal programs cooperating with the BIA through a Wildland Fire Management Cooperative Agreement) wildland fire resources. Line Officers and Fire Management Officers are responsible for ensuring that the appropriate Severity Support FireCode is used by their resources when assigned to any Severity activity on those jurisdictions instead of the FireCode issued on the Resource Order.

As a reminder, to improve management and tracking of Severity funding and expenditures, new FireCodes for Severity will be created and distributed on an annual basis. All Severity FireCodes will be open for two years with an intent of operational use during the first year, and invoice and other fire businesses catch up in the second year. The two-year period begins at the creation date of the Severity FireCode.
