The BIA has determined that the criterion related to the public safety risk, #1a, outweighs the other listed criteria. All eligible high-hazard potential dams will be first ranked by their public safety risk. This aligns with the mission of the BIA Dam Safety Program, which is to make BIA dams as safe as practically possible. Please review the criteria and their individual weights listed below.
