In compliance with the regulations of the National Environmental Policy Act (NEPA) of 1969, as amended, for the proposed Supplemental for information tiering off of an existing Environmental Assessment for Petro Hunt, LLC Inc., to drill two additional wells (Fort Berthold #150-94-3B-10-1H and Fort Berthold #1551-94-34C-27-1H) to explore the potential of the Middle Bakken Formation, on the approved Fort Berthold #150-94-3B-10-1H and Fort Berthold #151-94-34C-27-1H dual well pad, on the Fort Berthold Reservation, a Categorical Exclusion has been completed.

Nature of Proposed Action: The purpose of the proposed action is to authorize Petro-Hunt to drill two additional wells (Fort Berthold #150-94-3B-10-2H and Fort Berthold #151-94-34C-27-2H) to explore the potential of the Middle Bakken Formation, on the approved Fort Berthold #150-94-3B-10-1H & Fort Berthold #151-94-34C-27-1H Dual Well Pad. The Fort Berthold #150-94-3B-10-1H & Fort Berthold #151-94-34C-27-1H wells drill into the Three Forks Formation. No new surface disturbances will be associated with the well pad.

1. Purpose and Need for the Proposed Action

Petro-Hunt, LLC (Petro-Hunt) is proposing to drill two exploratory Middle Bakken Formation oil wells on the Fort Berthold Indian Reservation to evaluate and possibly develop the commercial potential of natural resources. Developments have been proposed on land held in trust by the United States in McKenzie County, North Dakota. The Bureau of Indian Affairs (BIA) is the surface management agency for potentially affected tribal lands and individual allotments. The BIA also holds title to subsurface mineral rights. The economic development of available resources and associated BIA actions are consistent with BIA's general mission. Leasing and development of mineral resources offers substantial economic benefits to the Three Affiliated Tribes of the Mandan, Hidatsa, and Arikara Nation and to individual tribal members.

The purpose of the proposed action is to authorize Petro-Hunt to drill two additional wells (Fort Berthold #150-94-3B-10-2H and Fort Berthold #151-94-34C-27-2H) to explore the potential of the Middle Bakken Formation, on the approved Fort Berthold #150-94-3B-10-1H & Fort Berthold #151-94-34C-27-1H Dual Well Pad. The Fort Berthold #150-94-3B-10-1H & Fort Berthold #151-94-34C-27-1H wells drill into the Three Forks Formation.

2. Authorities

Oil and gas exploration and development activities are conducted under authority of the Indian Mineral Leasing Act of 1938 (25 United States Code [USC] 396a, et seq.), the Indian Mineral Development Act of 1982 (25 USC 2101, et seq.), and the Energy Policy Act of 2005 (42 USC 15801, et seq.).

3. Legal Land Description for Proposed Action

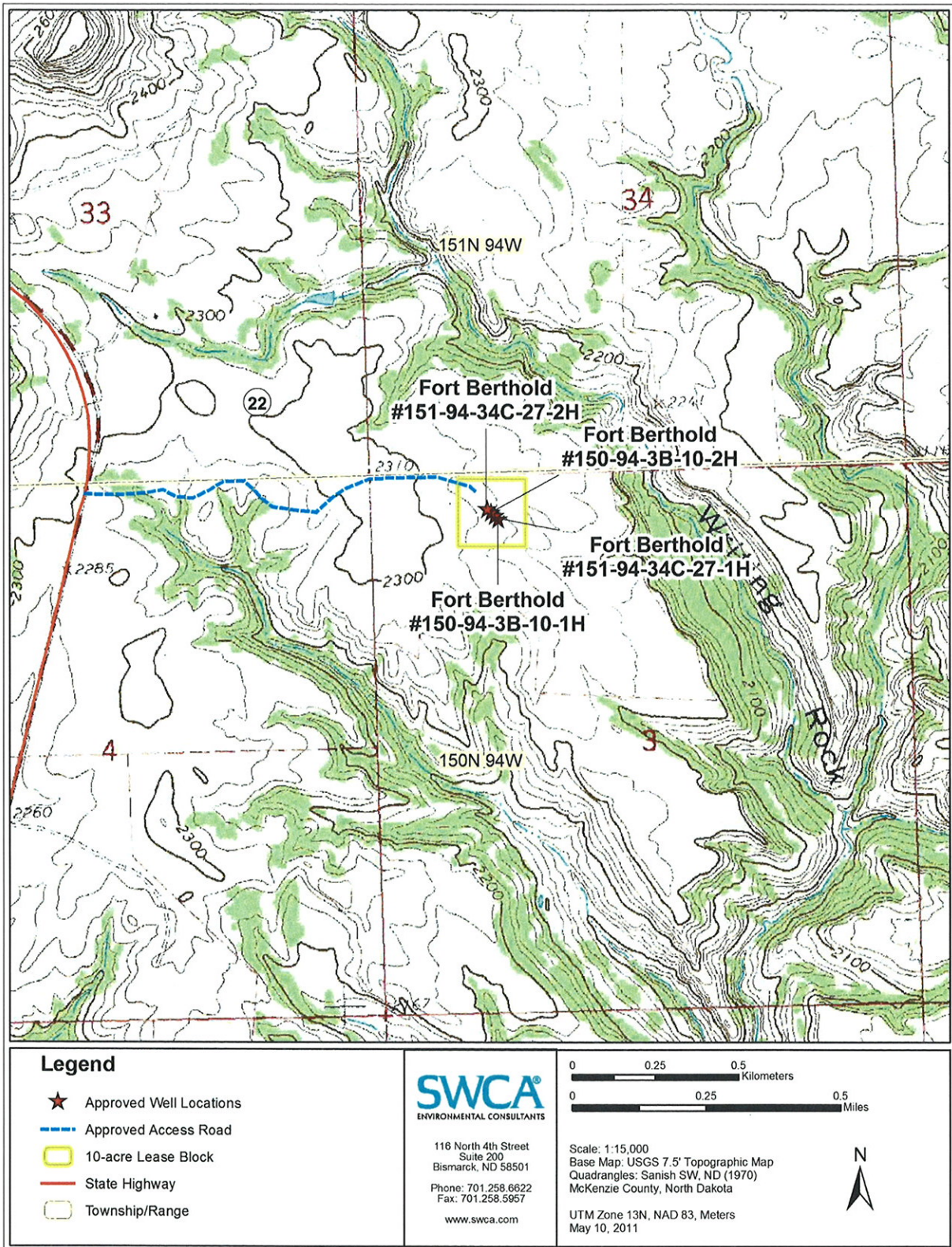
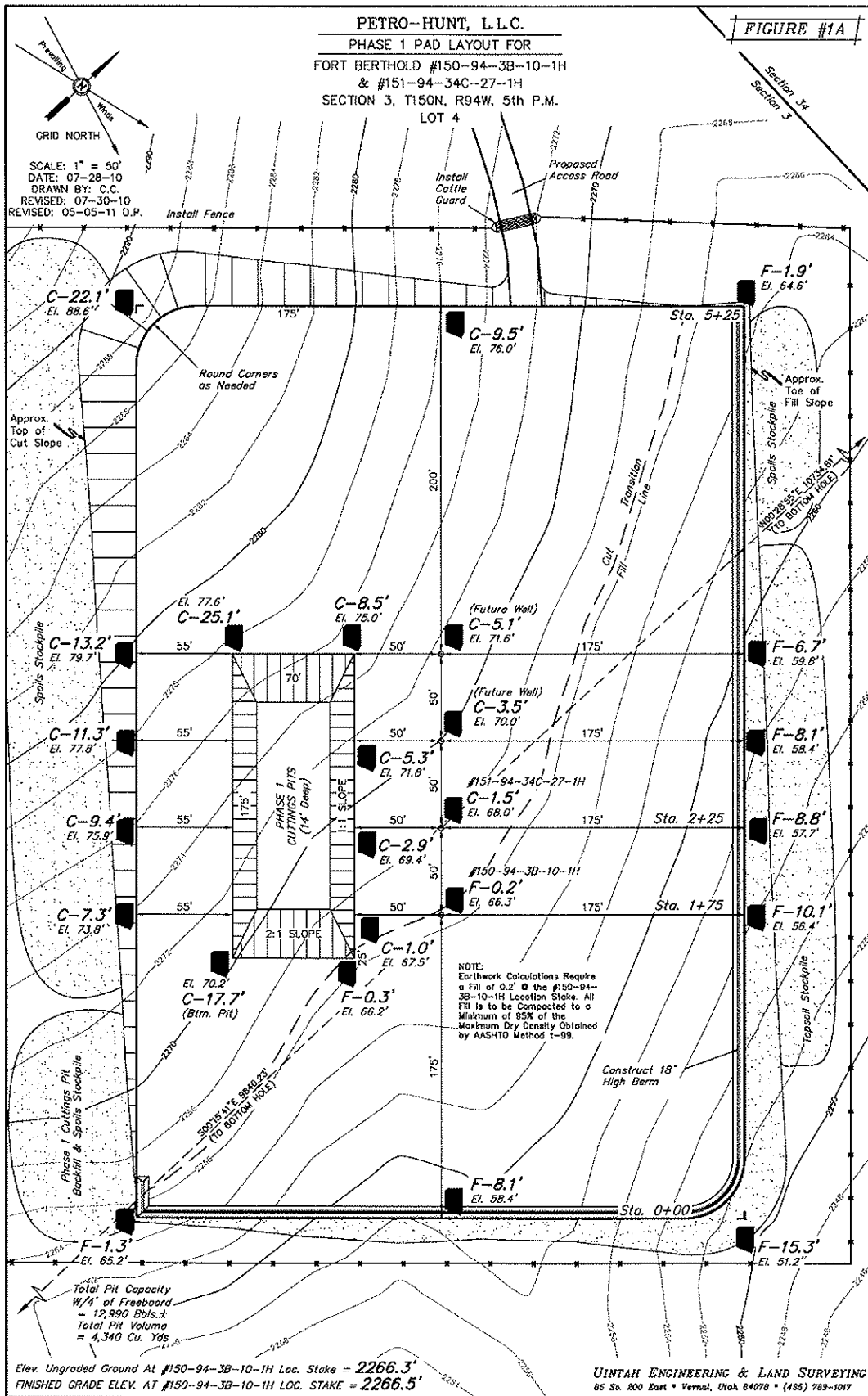


Figure 1. Map of the Fort Berthold #150-94-3B-10-1H, Fort Berthold #151-94-34C-27-1H, Fort Berthold #150-94-3B-10-2H, and Fort Berthold #151-94-34C-27-2H Location.

The well pad is approximately 8.1 miles northwest of Mandaree, North Dakota, in the NW $\frac{1}{4}$ NW $\frac{1}{4}$ of Section 3, Township (T) 150 North (N), Range (R) 94 West (W), 5th Prime Meridian (PM) McKenzie County, North Dakota (Figure 1). The proposed Fort Berthold #150-94-3B-10-2H well will have a bottom hole located approximately 9,907 feet south and 502 feet west of the surface location, in the SW $\frac{1}{4}$ SW $\frac{1}{4}$ of Section 10, T150N, R94W, 5th PM McKenzie County, North Dakota. The proposed Fort Berthold #151-94-34C-27-2H well will have a bottom hole located approximately 10,666 feet north and 557 feet west of the surface location, in the N1/2 NW $\frac{1}{4}$ of Section 27, T151N, R94W, 5th PM McKenzie County, North Dakota (Appendix A).

4. Scope of Work for Proposed Action

Petro-Hunt proposes to drill two additional wells, which will enter the Middle Bakken Formation, on the approved dual well pad. There will be no additional surface disturbance to the well pad or access road.

5. Cultural Resources

The cultural resource inventory of this well pad and access road was conducted by personnel of SWCA Environmental Consultants, using an intensive pedestrian methodology. Approximately 19.75 acres were inventoried on May 11, 2010, for the well pad and access road (Lechert 2010¹). No historic properties were located that appear to possess the quality of integrity and meet at least one of the criteria (36 Code of Federal Regulations 60.6) for inclusion on the National Register.

6. Applicable National Environmental Policy Act (NEPA) Document(s)

Finding of No Significant Impact: *Petro-Hunt, LLC: Fort Berthold #151-94-34C-27-1H and Fort Berthold #150-94-3B-10-1H* (October 2010).

7. NEPA Adequacy Criteria

This document has identified the above-mentioned previously prepared NEPA document, which adequately describes the environmental consequences of the newly proposed action described herein, and meets the following NEPA Adequacy Criteria.

1. The proposed action is substantially the same action and at the site specifically analyzed in the existing NEPA document.
2. The range of alternatives is reasonable with respect to the current proposed action in the existing NEPA document, which appropriately considers and analyzes current environmental concerns, interests, and resource values.
3. The existing analysis and conclusions are adequate in the existing NEPA document. The analysis is still valid in light of new studies or resource assessment information.
4. The methodology and analytical approach used in the existing NEPA document continues to be appropriate for the proposed action.
5. The direct and indirect impacts of the proposed action are unchanged from those identified in the existing NEPA document.
6. The cumulative impacts that would result from implementation of the proposed action are unchanged from those analyzed in the existing NEPA document.
7. A 30-day comment period involving public input and interagency review was used in the development of the existing NEPA document.

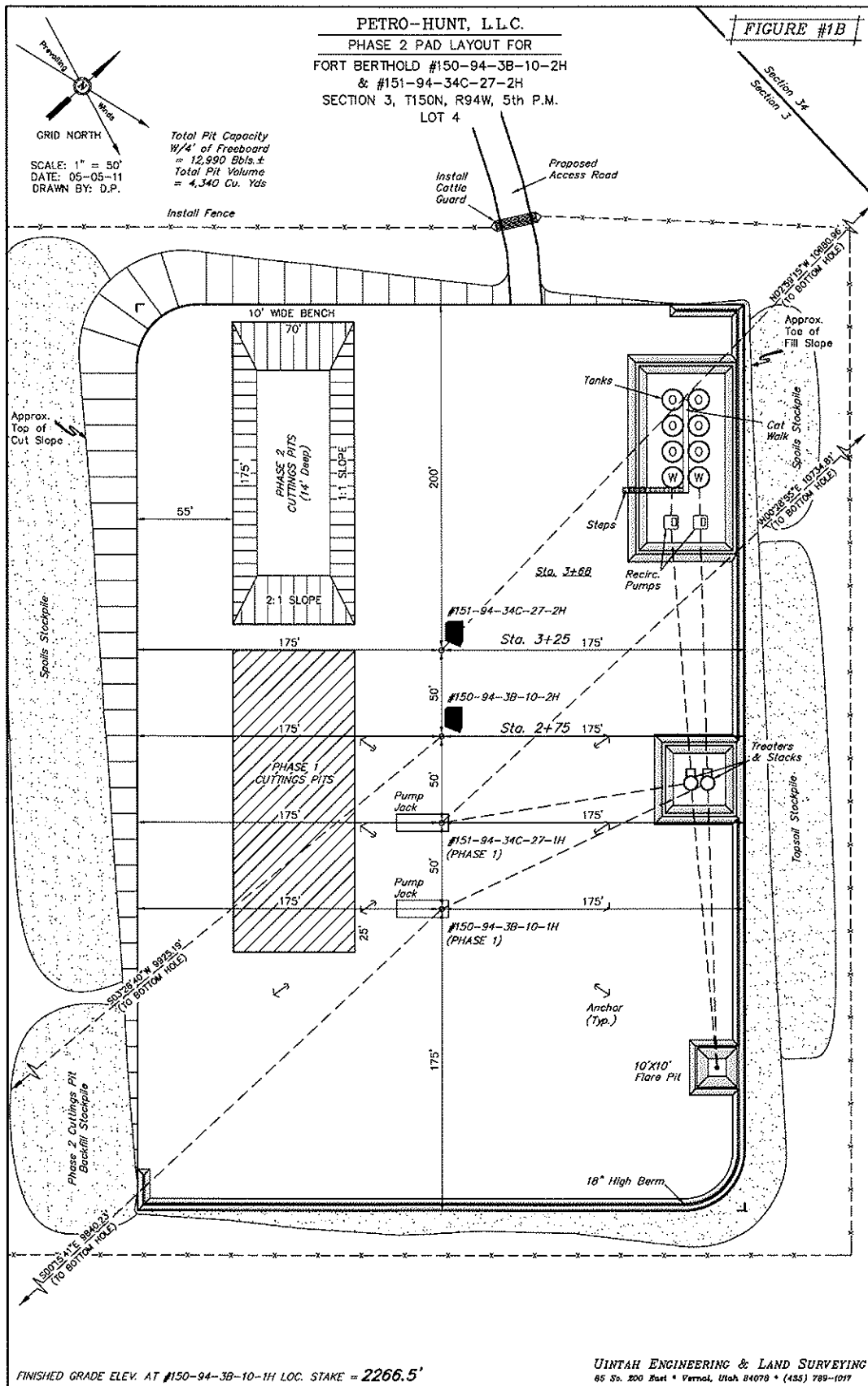

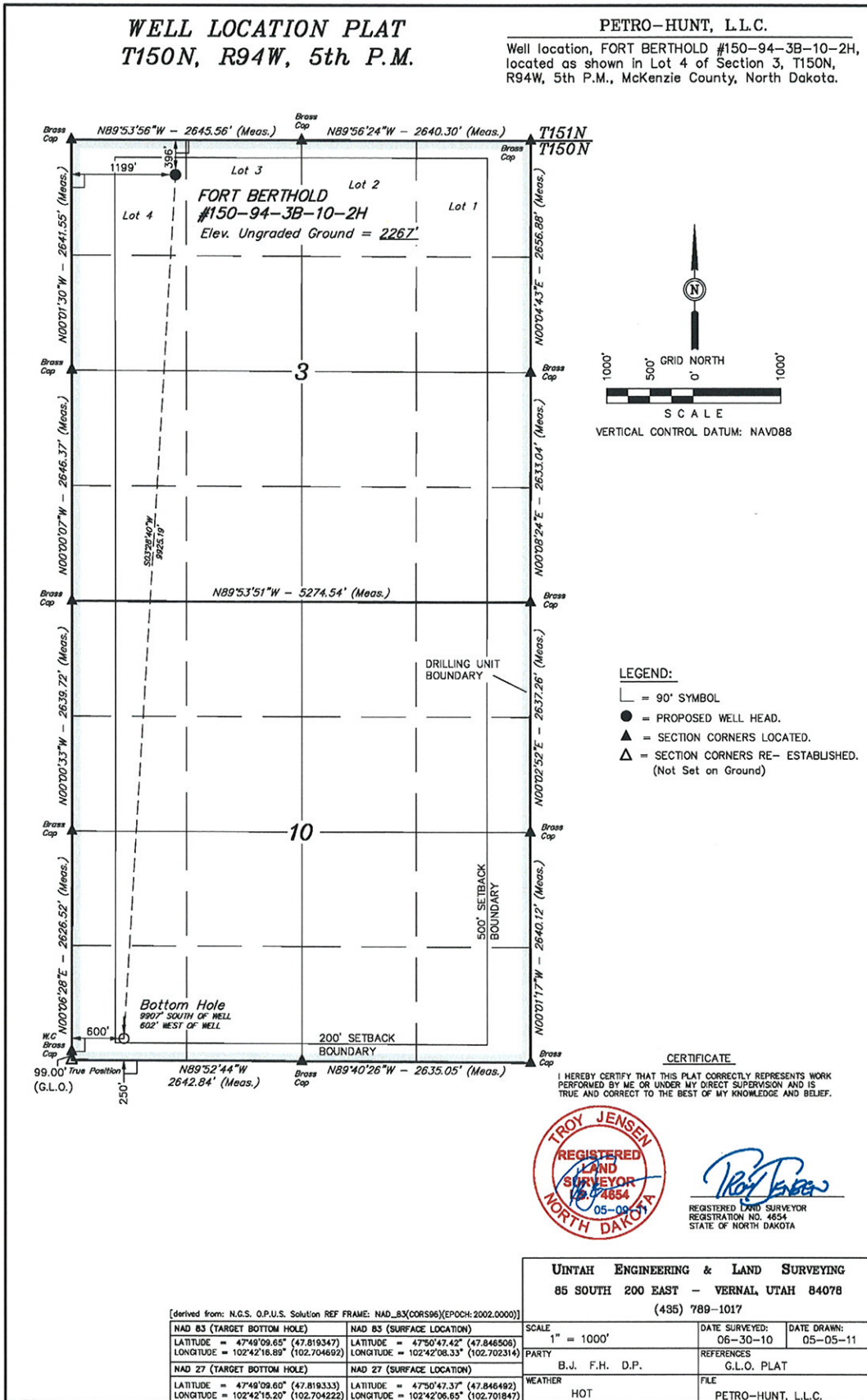
