Subject: Accessing the Wildland Fire Decision Support System (WFDSS)

A memorandum titled "*WFDSS Transition* – Schedule and Action Items" was issued March 5, 2009. It described WFDSS and the importance for implementing this system during this fire season. The purpose of this follow-up memorandum is to provide information for agency and tribal administrators to gain access to WFDSS. To accomplish this, the administrator must utilize the Internet and connect to the following URL. Once the webpage loads (Illustration 1), the administrator must click on the "Request new account" link.

The user will now see a "Request User Account" screen (Illustration 2). Please fill this out and click on the "Submit Request" button. The same "Request User Account" screen you just submitted will return blank. Note at the time of this memorandum, there is a bug in the system that will require completing the "Request User Account" screen a second time. Click on the "Submit Request" button again, and the "Request User Account" screen will return yet again. Although it does not communicate that you were successful, your profile is now created.
