- Submit Fiscal Year 2015 Emergency Stabilization (ES) and Burned Area Rehabilitation (BAR) electronic plans to Myron Hotinger, National BIA BAER Coordinator, within fourteen days of completion.
- Submit Fiscal Year 2015 Emergency Stabilization (ES) and Burned Area Rehabilitation (BAR) funding request to Myron Hotinger, National BIA BAER Coordinator and Darryl Martinez, Inter-Regional BAER Coordinator within 5 days of discovery of need, ongoing.
- Fiscal Year 2015 Emergency Stabilization (ES) and Burned Area Rehabilitation (BAR) projects and accomplishments are updated quarterly by the BIA Regional office in the National Fire Plan Operations & Reporting System (NFPORS)
- Fiscal Year 2015 Emergency Stabilization (ES) and Burned Area Rehabilitation (BAR) electronic annual or final accomplishment reports will be submitted by the BIA Agency office to the BIA Regional BAER Coordinator and Myron Hotinger, National BIA BAER Coordinator by September 15th.
