### BUREAU OF INDIAN AFFAIRS TRAINING SESSION OPEN TO PUBLIC FINAL RULE: RIGHTS-OF-WAY ON INDIAN LAND

Monday, February 29, 2016

2 p.m. - 4 p.m. Eastern Time

**The Bureau of Indian Affairs (BIA) is offering a training session on the new rule governing rights-of-way on Indian land.** The new rule amends 25 CFR 169, to replace regulations that were last updated over 30 years ago. (The published rule is available at 80 Fed. Reg. 72492 (November 19, 2015)). The new rule reflects modern requirements for rights-of-way and the need for faster timelines and a more transparent process for BIA approval.

**Who should join this training session?** Grantees and potential grantees of rights-of-way on Indian land and owners of Indian land who want to know more about the new rule should join this training session.

**How will the training session be held?** The training session will be held by webinar. The webinar will allow you to see training slides as they are presented. To hear audio with the webinar, you must also call the telephone number provided to join the teleconference.
