Dear Tribal Leader:

The Government Performance and Results Act (GPRA), as amended, requires that Federal agencies develop strategic plans that present the agency's vision, goals, strategies, and performance measures to achieve desired outcomes and evaluate program performance. The Department of the Interior (DOI) will begin revising its Strategic Plan for Fiscal Years 2014 – 2018 (DOI Plan) and requests your input and participation, through tribal consultation, to ensure that the needs of American Indians and Alaska Natives are adequately addressed.

Once DOI's Plan is revised, Indian Affairs (IA) will begin developing its Fiscal Year 2018 Indian Affairs/Tribal Strategic Plan (IA Plan). The IA Plan will complement and provide greater detail on the priorities of Indian Country as presented in the DOI Plan.

To ensure that the DOI and IA Plans reflect the diverse and unique needs of Indian Country, we will host two webinar sessions on **Wednesday, August 24, 2016**, and **Wednesday, August 31, 2016**.

The deadline for comments is **September 1, 2016**.
