### Handbook Updates

- Timber Sale Contract and Permit Forms and Standard Provisions.
  - Under revision as a precursor to revision of 53 IAM Handbook 3 Contract Sales of Forest Products and Handbook 4 Permit Sales of Forest Products.
- 53 IAM Handbook 7 *Forest Trespass* in late stages of revision, may release by end of CY.
- Forestry Collections and Distributions Handbook in late stages of revision, target release March 2017.

### **TAAMS Re-Platform**

- The new web-based TAAMS should be fully deployed and operational as of mid-July.
- Please report any problems to me.
- TAAMS Forestry Operations Group will meet in January to evaluate the new TAAMS and prioritize enhancements and bug fixes.
- Deploying TAAMS to Tribal personnel is still complicated.

### **Upcoming TAAMS Training**

- Advanced: Portland, Oregon, January 2017.
- Advanced: Phoenix, Arizona, spring 2017.
- Thoughts on overhauling the training program.
  - Better targeted training.
  - Completely in-house training.

### **Training**

- MRO Forestry last put on a training in 2012.
- To better meet our mission, a combined training session is planned for February 2017.
- Need to identify a location.
  - Need conference room for 50+ people and 2 smaller rooms for 30 each.
  - Need nearby forest stand for field training.
  - Need local person to assist with logistics.
- Training planning starts next Monday.

### Year-End Funds Available

- Unspent budget funds are available for yearend projects now.
- For Inventory/Planning or Forest Development Projects, Contact Kristen Lease.
- For everything else, contact Matt Anderson.
- Proposals:
  - Up to \$150,000. No lower limit.
  - Submit by 8:00 AM CDT August 22, 2016 (possibly earlier).

### **Funding Priorities**

- Training and other employee development.
- Boots on the ground, especially fractional FTEs. Do not rely on this nonrecurring funding for new staff.
- Equipment.
- One-time projects or kickoff projects.

### **Future Funding Allocation**

- Regional TPA budget currently comes in two parts, base funding and discretionary.
- Central Office wants to program more of the discretionary funding to protect it from budget cuts.
- Need suggestions on how to program the discretionary funds, about \$500,000 annually.
  - New positions?
  - Overall base increases?
  - Gold-plated Relaskops?
- Regional Foresters will discuss this at a meeting in mid-December.
