Dear Tribal Leader:

As part of our efforts to promote economic development in Indian Country, we are seeking your input on the need to update the “Licensed Indian Traders” regulations currently found at 25 C.F.R. Part 140. The current regulations were promulgated in 1957 and have not been comprehensively updated since 1965. We seek to modernize these regulations through the formal rulemaking process to reflect the current Federal policy of promoting tribal self-determination.

We previously raised this issue in an advance notice of proposed rulemaking (ANPRM). In response, we received comments from 37 Tribes and 8 tribal organizations, as well as several non-tribal commenters. *See* 81 Fed. Reg. 89,015 (Dec. 9, 2016). Several tribal commenters acknowledged that the multijurisdictional issues associated with trade in Indian Country are burdensome and negatively impact their ability to conduct business. Additionally, a significant number of tribal commenters stated that they have difficulty providing basic services on their land and to their members in the current economic climate.

The ANPRM was informed by a study released on May 4, 2016, by the Native Nations Institute and the Harvard Project on American Indian Economic Development, which sets forth proposals for reducing financial constraints on tribes and bolstering tribal economies. The comments we received in response to the ANPRM suggest that implementing some of the study’s recommendations may benefit Indian Country and surrounding communities and states. In your comments, please provide any information you did not include in your comments on the ANPRM. We are particularly interested in the following:

1. Specific projects that your tribe or tribal organization cannot initiate or approve under existing regulatory requirements, but which you believe could move forward if new regulations gave tribes greater economic flexibility. For each project include:
  - a) details regarding Indian Country capital investment under the project;
  - b) details regarding the annual tribal revenue associated with the project;
  - c) the number of Indian Country jobs that could be created under the project; and
  - d) any specific impediment preventing forward progression on your project.
2. Any economic impact studies on the benefits of Indian Country economic development to surrounding communities.
3. Specific treaty provisions that require the United States to protect tribal economic interests.

This economic data is needed to determine whether the revised 25 C.F.R. Part 140 would contribute to economic stimulus, jobs, and prosperity to Indian Country and the rest of the Nation. Tribal participation is critical to this important effort.
