Kayla Mack, Federal Mediation and Conciliation Service (FMCS), provided a welcome and meeting overview. Today's meeting consists of two primary portions separated by public comment opportunities. The first portion we will hear an update from the Committee and have a discussion on protocols. This is followed by a recess for caucuses. Once back from caucus, there will be a discussion on the topics to be discussed in negotiations. Followed by discussion on next meeting and FY23-Q1 hybrid meetings. #### APPROVAL OF OCTOBER 3, 2022, MEETING MINUTES

Regina Gilbert, ADFO, reminded the Committee that the draft meeting minutes were sent out by email in advance of this meeting so that there was time to review. Are there any edits prior to approval?

Ron Allen did not look at them closely. Wondering about tabling approval, as he was not sure the Committee is prepared to approve. He deferred to Melanie.

Melanie Fourkiller has reviewed and has no edits. Melanie posed the question if anybody else needs more time [to review the minutes]? Gerry Hope posed the question for a quick review[of the minutes] in tribal caucus this morning. Comment in chat: Sandra Sampson reviewed and has no edits. Ron Allen requests to table [approval of the minutes] until after caucus.

ADFO Gilbert approved tabling approval of minutes until after caucus.

#### COMMITTEE OPERATING PROTOCOLS AND NEGOTIATION PROCESS

FMCS-facilitated discussion and deliberations began at 1:30 pm ET.

- 1. Protocols Subcommittee Report-Out:
  - A) Subcommittee Tribal Leads: Gerry Hope and Will Micklin
    - Mr. Hope called on Matt Jaffe to take the lead in reporting:
    - Matt Jaffe: The news to report is good news. The two sides made a great deal of progress. The workgroup decided that tribal committee will propose different route than the original 12-pages of protocol proposed during the first plenary meeting on August 29. Tribal Committee proposed to put aside the [19-page] redline version and turn to the Department of Health and Human Services Title V protocol developed in 2001 and 2002. From the DHSS Title V protocol, the Tribal workgroup put together some of consensus points and modified the Title V five-page protocol and sent it to the Federal Committee Members. The Tribal Committee members believe that this will streamline the Negotiated Rule Making process and let the Committee get down to negotiating and not get tied up with procedures. This is also in line with the Assistant Secretary's (AS-IA) statements that FACA is not intended to get in the way of this Committee's work. This proposal was sent to the Federal Committee members with a few issues to discuss. This is an eight part charter: (1) participation, (2) meetings, (3) decision making, (4) agreement, (5) discussion, (6) facilitators, and (7) leadership team.
    - Will Micklin: Mr. Jaffee's summary was succinct. DHHS Title V covers all necessary
      portions with our few additions to fit this committee. Discussion with our Federal
      Partners will focus on the following sections of the charter: Alternate tribal
      representatives, recognition of agenda for approval, facilitators chairing the
      meetings, use of Roberts Rules of Order, and Committee Participation for final rule.
    - Gerry Hope: Thanks to the attendees from both the Tribal and Federal committee
      members who took the time to meet with their various meeting schedules. The
      Federal mediators had positive role in the meetings. Hopefully the results of our
      meetings will be comfortable with both sides; I believe we are close to the finish.
  - B) Subcommittee Federal Leads: Jody H. Schwarz and Sharee Freeman
    - Agree it was collaborative process with a lot of ground to cover. Appreciate the
      suggestion to switch to DHHS Title V provision. Agree that we are close to
      consensus. The federal committee members want to be mindful of what FACA
      requires and make sure the process of this committee we interpret in such a way
      that it benefits and does not hinder this committee. Open, willing, and want to
      engage with Tribal colleagues. Still a few issues to discuss before reaching
      consensus. It is not necessary for remaining (federal) members to speak at this
      time.
    - Sharee Freeman: DFO started with protocols from Title IV rulemaking which Title
      V is very similar to. At the beginning of this process, we were given the FACA
      protocols used normally—which were different than Title IV. That's how it [draft
      protocols from august 29] started. We are delighted now that we have the
      support from AS-IA and tribes to use the Title V protocols.

- 2. Committee Deliberations: Ms. Mack posed the question if the Protocols Sub committee wishes to continue the deliberations on the protocols?
  - Jody Schwarz asked to go into caucus to finish discussion.
  - Ms. Mack asked if there was any objection. Hearing no objection, will break the group into tribal and federal caucuses.
  - Melanie Fourkiller requested the estimated time to be in caucus?
  - Jody Schwarz responded with about 15-20 minutes--so to return at top of hour.
  - Committee has no objections and defer to to Protocols subcommittee to complete the Protocols.
- 3. Protocols subcommittee breakout meetings for the protocols, 2:10 p.m. to 4:57 p.m.
  - At 4:59 p.m., Ms. Caruso brought the committee back from caucuses.
  - Tentative language drafted under participation section is projected on the screen for discussion.
  - Gerry Hope comments on proposed language to include intent on DOI looking for additional funding.
  - Ron Allen does not see the language Mr. Hope is seeking. Comments that he sees that DOI is providing for primary member travel funding, and that alternate member travel will be subject to any additional funding. Personally, can live with the language as proposed. He will take the upcoming TIBC meeting as a time to make the case for use of carry over funding.
  - Melanie Fourkiller agrees; will move forward on the current budget. Provide for the alternate now, knowing that Committee is seeking additional funding for the years down the road. IT is important for the alternates to be there for committee discussions.
  - Gerry Hope: In the subcommittee, there were strong words of support from the Federal team, but need to hear stronger sense of commitment. Need to find additional funding for alternates.
  - Buster Attebery: same question as Chairman Allen. Last sentence "where possible" does it mean that you can't find a room with phone or video?
  - Sharee Freeman: Will definitely have telephone, but uncertain if video.
  - Ron Allen: in previous meeting you reference updated meeting rooms with audio/visual capacity.
  - Sharee Freeman: Not all do, but the ones we currently have reserved do.
  - Rose Petoskey: agree that federal side intends to have alternates travel to the meetings.
  - Ron Allen: participating in TIBC, they know they have flexibility—just not sure on how much.
  - Sharee Freeman: Provided budget for those that asked for it. Will run back the numbers and take a look.

- Ms. Caruso asked ADFO to test for consensus via roll call?
- ADFO: Any concerns or needs for edits before consensus?
- Ron Allen not on the call, defer to Melanie Fourkiller. Rely on good faith of AS-IA to seek additional funding. Ready to move it forward.

#### AGENDA SETTING

- Ron Allen: Will circle back on agenda for December meeting? Send recommendation to Matt Jaffe on low hanging fruit for discussion?
- Ms. Caruso: FMCS will be convening Leadership Teams meetings to discuss travel guidelines: As invitational travelers DOI will make arrangements pursuant to the Temporary Duty Travel Policy.
- That policy provides that:
  - a) Invitational travelers will receive the same allowances as DOI employees.
  - b) Government contract flights.
  - c) DOI does not reimburse for seat upgrades.
  - d) Lodging at federal per diem rate.
  - e) No reimbursement of additional fees.
  - f) Meals provided would be deducted form per diem. Perdiem is for breakfast, lunch, and dinner
  - g) Invitational travelers not allowed personal vehicles.
  - h) Reimbursed for taxi/shuttles/uber/lyft, airport parking. 20% tipping.
  - i) All expenses require receipts:
  - j) Non reimbursable expenses are listed on the GSA website
  - k) Travel voucher process: submit the receipts then the approvers review and sign. Reimbursements for per diem are made by direct deposit to banking.

- Melanie Fourkiller: I am interested in keeping momentum going.
- Ron Allen: There can be designated key people on each subject matters. Can Director Freeman identify federal key people as well?
- Sharee Freeman: Can the tribal representatives get a list of those people so (Director Freeman)
  can review and develop the list of federal representatives. So that they can be working forward
  together.
- . Ms. Caruso: will work this evening to get a date for the Leadership Team to meet.
