Please accept this letter as our formal request to withdraw our request for trust acquisition for property located in Pontotoc County described as:

The N/2 NW/4 SW/4 of Section 32, Township 4 North, Range 6 East, Pontotoc County, Oklahoma, containing 8.9 acres, more or less.

A copy of the Certificate of Survey and the original October 5, 2000 letter requesting the property be taken into Trust are included with this letter. It has been nearly a decade since our request and there has been no action. We now find that our original plans have changed and we no longer require this property for its original intent and therefore withdraw our request to have the property placed U.S.A. in Trust for the Chickasaw Nation.
