Northern Cheyenne Tribe, Section 20 gaming application

Dear Mr. Skibine,

On October 28, 2008, your office issued a two-part determination, pursuant to the Indian Gaming Regulatory Act, 25 U.S.C. § 2719(b)(1)(A), finding that gaming on trust lands of the Northern Cheyenne Tribe – located to the south of their reservation in Montana – would be in the best interest of the Tribe and its members, and would not be detrimental to the surrounding community.

As Governor of the State of Montana, this letter constitutes my concurrence in your determination of October 28, 2008. My concurrence is required under the Act prior to any gaming taking place on those lands. 25 U.S.C. § 2719(b)(1)(A); 25 C.F.R. Part 292.13 (d). The trust lands proposed for gaming comprise 160 acres, located in Big Horn County, and are described as follows:

T.8 S., R.40 E. P.M.M. Sec. 23, SW ¼ NE ¼, N ½ SE ¼ Sec. 24, NW ¼ SW ¼

A Class III gaming compact, between the State of Montana and the Northern Cheyenne Tribe, is in effect until June 3, 2017. However, the compact is limited to gaming within the Reservation as established by the Executive Orders of November 26, 1884, and March 19, 1900. Therefore, prior to any gaming occurring on the Tongue River trust parcels, the existing compact must be amended by mutual agreement of the State and the Tribe. Any remaining issues with regard to the scope of gaming or the operation of the facility will be addressed in the compact amendments.
