ADMINISTRATIVE ORDER

NOW on this 29th day of December 2022, the undersigned Chief Magistrate, being duly appointed, does FIND that it is necessary for the Court of Indian Offenses to implement the attached bail schedule for the purpose of setting bail for persons charged with criminal offenses.

Pursuant to the provisions of 25 C.F.R. §11.310, the Magistrate shall set bail in an amount which is reasonably calculated to assure the appearance of the person charged at any time as required. Nothing in this Order or the attached schedule shall prohibit a Magistrate from using his or her own reasonable judgment to establish a higher or lower bail amount or other conditions that are appropriate for the alleged charges of the accused.

Bail shall be posted in the form of a money order, cashier's check or by paying online at <u>www.pay.gov</u> in the amount prescribed by the Magistrate and pursuant to this bail schedule. If a warrant has been issued, the amount of bail specified in the warrant shall be paid in accordance with the payment options herein.

A person who is intoxicated or impaired by alcohol, drugs or other intoxicants, shall not be allowed to post bail for a minimum of six (6) hours and thereafter by order of the Court if the officer or person in charge of detention is affirms that said person is sober and/or in sufficient control of his/her faculties and will pose no threat to themself or the general public.

This Order supersedes any previous bail schedule. The attached fee schedule is hereby to be implemented on January 1, 2023.
