My name is (b) (6), and I serve as the (b) (6) for the Citizen Potawatomi Nation (CPN). We are formally requesting a complete and detailed listing of all property items our Tribe has received from the Department of Defense (DoD) Defense Logistics Agency (DLA) Disposition Services (formerly known as the Defense Reutilization and Marketing Office, or DRMO), via the Bureau of Indian Affairs (BIA).

This request is part of an ongoing fraud investigation involving two former employees, (b) (6) who are alleged to have participated in an asset laundering scheme. To assist our external forensic auditors in this investigation, we are seeking a comprehensive record of all items received by CPN through the BIA from DLA-DRMO. This information is necessary for preparing a report for our insurance provider and the Office of Inspector General, which has already received our preliminary findings.

These assets were obtained under BIA DoDAAC No. (b) (6), with CPN identified by Compact No. (b) (6).
