The records we are requesting almost certainly contain exculpatory evidence needed to effectively represent a client in a pending criminal case against him.

Then, we reached out to (b) (6) Program Analyst at the Phoenix BIA District Office, who instructed us to file a FOIA request in order to access any records dating earlier than 2019.

DNA - People's Legal Services is requesting these records because we are the official Hopi Public Defender, appointed by the Hopi Tribal Court to defend a criminal case against a client. These records are directly related to his defense and almost certainly contain exculpatory information necessary to defend our client's case and therefore necessary for us to provide effective assistance of counsel. The case against him is based exclusively on the word of the alleged victim, (b) (6) and contains zero physical evidence. We believe these police records contain information that is admissible in court to show that she has committed specific acts of untrustworthiness, which is admissible on cross-examination under the Federal Rules of Evidence (Hopi Courts use the Federal Rules of Evidence).

His case is set for trial on October 22, 2024 in Hopi Court, so this request is very time sensitive.
