These children were removed from my care and ultimately placed under the jurisdiction of the Chickaloon Village Traditional Council in Alaska. The removals involved cross-state actions initiated in Oklahoma and finalized in Alaska. I believe this case involved the improper application of the Indian Child Welfare Act (ICWA), as well as serious due process violations including denial of legal representation, lack of notice, and improper jurisdictional transfers.
