Pursuant to the Freedom of Information Act, 5 U.S.C. § 552, I respectfully request access to genealogical and tribal records in your possession that may pertain to my ancestors, most of whom lived prior to the 1870 federal census, and were recorded under various racial classifications including American Indian, Mulatto, Negro, and Colored. This request seeks to uncover vital records, tribal enrollment, land claims, migration, or probate documentation for the following individuals and family groups:□

This is a formal request made under the Freedom of Information Act (5 U.S.C. §552) and the Privacy Act of 1974 (5 U.S.C. §552a), for the release of all documents and correspondence maintained by the Bureau of Indian Affairs (BIA) or the U.S. Department of the Interior relating to communications □ between myself and the agency during the period of January 1, 2014 through December 31, 2015.□

During this time, while I was incarcerated in the State of California, I authored a letter addressed to the Bureau of Indian Affairs, listing the names of my family members and requesting a genealogical verification of our Native ancestry. In response, I received a written letter from the BIA affirming that my family members were located on the Final Dawes Roll and were affiliated with up to six federally recognized tribes.□

I am now requesting the following records:□

1. A certified copy of the letter sent to me by the Bureau of Indian Affairs in 2014 or 2015 confirming tribal lineage and Dawes Roll enrollment;□

2. A copy of my original letter or inquiry submitted during incarceration listing my family members;□

3. All tribal correspondence, internal notes, or genealogical data used to perform the verification;□

I am identified by AZ court order as the Personal Representative for my late Mother's Estate. I am requesting copies of all tribal asset documents (i.e., home site lease, allotted lands, grazing permit, etc.) to start the probate process on my late mother's estate. (b) (6) register under Western Navajo Agency, was deceased on (b) (6)

Probate Decision to determine how Kay Red Horse inherited property. Our authority to request this information is attached. We represent the Executor of (b) (6) Estate and are attempting to facilitate the disposition of her probate estate. Attached you will find Letters

I am requesting a copy of the grant of a perpetual right-of-way to the Arizona Highway Department that was approved by the United States on September 16, 1965 for the Nogales Highway Interstate 19; Project I-19-1 (8) Sections 23, 26, 27 & 35 Township 15 South, Range 13 East; Sections 2, 11, 14, 23 & 26 Township 16 South, Range 13 East, GS, AZ. □
