This FOIA request seeks all records, communications, memoranda, legal opinions, guidance, or policy documents related to the Bureau of Indian Affairs' handling of the July 2, 2025, Cold Springs Rancheria Election Committee Certification for the May 3, 2025, Tribal Council election. This includes any correspondence, emails, or notes concerning acknowledgment, recognition, or non-recognition of the certified election results; discussions of alleged election "irregularities"; internal deliberations regarding the contested status of the election; communications with law enforcement or outside parties regarding Tribal governance or access to Tribal property; and any legal or policy memoranda instructing BIA personnel to disregard the Tribe's Constitution, Election Ordinance, or Election Committee determinations. The records sought also include any challenges to the eligibility, qualification, or election of any Tribal Council member, including prior elections. The request covers actions by Central California Agency and Pacific Regional Office staff.□

The Tribe has experienced significant and ongoing harm due to BIA inaction and interference, including denial of access to its offices, frozen bank accounts, and disruption of essential government functions. The attachment provides a detailed description of each specific category of records requested. This request is necessary to document the Bureau's actions impacting Tribal sovereignty, access to trust resources, and lawful governance, and to preserve the Tribe's right to administrative review and appeal under federal law.
