LRP Publications is categorized as "representative of the news media" on the basis that it provides news in various periodicals (See Appeal No. 18-00010-A-FOIA Request No. 18-00074-F by Chief Privacy Officer Kathleen M. Styles.) Under FOIA, a representative of the news media is defined as "any person or entity that gathers information of potential interest to a segment of the public, uses its editorial skills to turn the raw material into a distinct work, and distributes that work to an audience." 5 U.S.C. § 552(a)(4)(A)(ii). To determine whether a requester qualifies as a "representative of the news media," the requester's past, present, and future work should be considered. Liberman v. U.S. Dep't of Transportation, 227 F. Supp. 3d 1, 11 (D.D.C. 2016).□

As of Oct. 13, 2006, the effective date of the final regulations implementing the IDEA, states must make available to the public the findings and decisions of state hearing officers after personally identifiable information has been removed. Authority: 34 CFR 300.513; 20 USC 1415(f)(3)(E) and 20 USC 1415(f)(3)(F), 20 USC 1415(h)(4),20 USC 1415(o)). According to Letter to Anonymous, 67 IDELR 188 (OSEP 2016), the state should not redact the names of the hearing officers, the district, and case numbers unless release of such information would result in the release of personally identifiable information.□
